It provides hands-on learning on Calgary Transit buses and CTrains. To ensure that this camp is right for you and your child, please refer to the below prerequisites:

- Have a mild to moderate disability
- Be between the ages of 15 21 years old.
- Can recognize numbers and words, as well as some ability to understand maps, read or tell time, and recognize text on help buttons and at stations.
- Shows interest in attending camp to gain sufficient knowledge on how to take Calgary Transit independently
